American Library Association President Report Lessa Kanani'opua Pelayo-Lozada Annual 2023

In my final report as President of the American Library Association, I must begin with gratitude. I am grateful for and humbled by the library workers across the nation who stand up for our professional values, who advocate for their communities, and who strive to provide equitable access to information for all who enter their physical or virtual doors. This year has been a tough one for us all as we adjust to living with COVID and face threats against our profession and selves through book challenges and harassment, but library workers are strong and continuing to push forward.

I would not be able to do all that I have done this year without our members, without our future ALA members, and without ALA staff. Partnership and collaboration have been key to this year, and together, we led for change on behalf of our brave communities.

Below highlights some of my activities since my <u>Spring 2023 Report</u>, but in no way even begins to scratch the surface of the myriad of support, resources, and programs offered through the association by our strong staff and members who make all of this possible.

National Library Week

National Library Week was a whirlwind of events, media coverage for ALA, and excitement and love for libraries. With the release of the Top 13 Most Challenged Books of 2023, I spent much of the week speaking to reporters from news outlets such as NPR and the Washington Post, and presenting on panels such as Judy Blume Forever with esteemed colleagues Leah Wolchok and Davina Pardo, directors of the Amazon Documentary Judy Blume Forever, author, advocate & retired librarian Pat R. Scales, Chris Finan the Executive Director of the National Coalition Against Censorship, and Suzanne Nossel the CEO of PEN America.

ALA-Allied Professional Association

The work of the ALA-APA Working Group to explore areas that ALA-APA might expand with greater financial capacity including but not limited to advocacy work on behalf of library workers, initiatives, and staffing began later than anticipated and the group will continue its work beyond June and bring recommendations to the ALA Executive Board under incoming ALA President Drabinski's tenure.

Branding Working Group

Work continues on the ALA Branding Working Group under the leadership of co-chairs ALA Past President Julius C. Jefferson Jr. and United for Libraries Past President Skip Dye with myself as their liaison to explore expanding ALA's brand to include public library supporters and lovers as well as to explore a replacement to the Libraries Transform Campaign. The committee will continue to explore opportunities, challenges, and barriers to this new strategy which will utilize monthly donations and the idea of a "Friend of ALA" and I will resume duties as co-chair in July with ALA Past President Julius C. Jefferson Jr.

Connect Live

During National Library Week, AASL President Kathy Lester and I hosted the ALA Connect Live "Our Brave Communities: Embracing School Librarians". President Lester moderated a panel providing an overview of the current state of school libraries from Keith Curry Lance, principal investigator for the IMLS-funded national study, "The School Librarian Investigation—Decline or Evolution?", as well as Liz Phipps-Soeiro highlighting efforts in Boston to increase the equity of access to certified school librarians; and Raegan Miller, Director of Development and Finance for the Florida Freedom to Read Project, and student organizer Cameron Samuels discussing building community support for school librarians fighting censorship.

ALA Interim Associate Executive Director Alan Inouye provided information on exciting legislation and support for library workers that came through during National Library Week, including the re-introduction of the Right to Read Act focusing on the importance of school librarians.

The session had over 500 registrants and strong engagement in the chat and Q&A from folks emphasizing the support and love of the full library ecosystem for school librarians, as well as key actions we can take to support and advocate for certified school librarians in every school.

Library Visits

I had the opportunity to visit Discoveries: The Library at the Mall, part of the Anne Arundel County Public Library system in Annapolis, Maryland. This vibrant location inside the Westfield Mall was bustling on a weekday afternoon with young patrons visiting their favorite hermit crab, teens getting a volunteer orientation for summer, and staff providing a warm welcome to visitors. Their Community Pantry is a highlight, distributing diapers, wipes, other baby supplies, and hygiene and menstrual products to anyone with a library card.
