Report from the Committee on the Status of Women in Librarianship

In alignment with COSWL's <u>charge</u>, members discussed issues related to women in librarianship and sent top three issues to ALA President, President-Elect, and Past President as well as to the ALA Interim ED. COSWL page with charge:

Issues related to women in librarianship:

 Many women don't want to travel to some states state (for a conference or event) where they can't receive care if they experience an emergency due to restrictions placed on women, e.g. pregnant women, etc.

NOTE COSWL members voted YES to take action related to the following issue "about ALA continuing to host conferences in states where a large portion of our attendees, if in a medical crisis, may not be able to receive appropriate emergency medical care."

ALA COSWL Statement Endorsed by the ACRL-Women and Gender Studies Section Executive Committee and the Social Responsibilities Round Table

The ALA Committee on the Status of Women in Librarianship calls on the ALA Executive Board to take expeditious action in support of women and people who are pregnant related to the matter of ALA continuing to host conferences in states where a large portion of our attendees, if in a medical crisis, may not be able to receive appropriate emergency medical care.

While the committee understands contractual obligations to have conference sites booked far in advance, we request that the conference committee explore considering the location of a conference site with local limitations on women's rights, when selecting future locations to ensure that all ALA members have equal access to emergency medical care if needed.

- 2. Cities and states trying to separate from ALA. For example, Georgia is attacking credentialing librarians. Since women represent about 87% of librarianship, this situation can affect a large part of our profession leaving women outside of the equal playing field.
- 3. Supporting women librarians- harassed by ideologies that do not respect autonomy of women. For example: librarians facing book bans, facing city councils, town halls, harassment online, harassment at their workplaces, attacks on their families, etc.

COSWL members worked as a team to present one event about Salary Equity and to review resources. At the beginning of the work year, members conducted an internal survey to identify issues of interest to

women in librarianship. COSWL's resources and webinars' themes are based on the survey.

COSWL Webinar:

"Salary Equity and Library Workers: Experiences from the Field on How to Make it Happen"
